Some items may be deemed acceptable after additional review and terms and conditions. Please check with us if you have any items in the below categories that you wish to upload prior to entering any Products or Experience in the Seller Portal.

- Alcohol, cannabis, controlled substances, drug paraphernalia, medications, drugs and narcotics, tobacco, e-cigarettes and e-juice/liquid, prescription and nonprescription pharmaceuticals and products that make health claims as well as associated equipment [designed for making or using drugs,] such as bongs, vaporizers, syringes, and hookahs
- Animals/insects alive or dead, products made with animal parts along with [vaccines], organs or corpses, ivory products, natural fur products, hides, etc.
- Collectible items including autographs and signatures and unauthorized reproductions
- Cosmetics that require medical professionals, cosmetics with tampered packaging, any items that don't comply with Health Canada requirements including labelling, expired products, products including controlled substances, and testers
- Electronics not certified with Innovation, Science and Economics Development Canada, illegal and modified devices, unlocking, jamming or converting data devices, refurbished hardware, codes and software of any kind
- Exotic skins including any animal skin or leather not derived from cow/calf, sheep/lamb, pig, goat or water buffalo. This includes but is not limited to: Lizard, Snake, Python, Alligator, Crocodile, Ostrich, Shark, Kangaroo and Stingray

- Food items that are deemed unsafe or recalled, expired food, foods containing drug claims, infant formulas, any food items not labelled or packaged by Food and Drugs Act, and food items prohibited from import into Canada
- Financial services, including virtual currency or stored value services, money transfer services, check cashing, foreign exchange or dealing, securities brokerage services, mortgage or debt reduction services, credit counselling or repair, debt collection, insurance, travel insurance, bankruptcy real estate offers or transactions, lending, or aggregation funds or factoring
- Artifacts, fossils, relics, remains, and sacred tribal items
- Funeral items including caskets, urns, grave markers, etc.
- Fur products (real fur) from animals raised, caught or killed for the use of fur including but not limited to: Mink, Fox, Chinchilla, Sable. Also fur products derived from wild animals such as Coyote and Beaver.
- Gambling services, such as lotteries, bidding fee auctions, sports forecasting or odds making, fantasy sports leagues with cash prizes, internet gaming, contests, sweepstakes or games of chance
- Gift Cards
- Hazardous items including any chemical substance or compound not intended for general consumer purchase or any products prohibited by Environment Canada or other regulatory agency
- IDs of any kind, any illegal car parts, license plates, vehicle tampering parts, products intended to bypass emission control or override automotive functions, and any illegal car functions including radar detectors
- Jewelry that does not comply with applicable laws or regulations including clarity enhanced white diamonds or diamonds that do not comply with Kimberly Process Certification Scheme, loose gemstones or jewelry that contains conflict materials

- Offensive items including those that display nudity or vulgar language, obscene material, are sexually suggestive or contain pornography, items that display or relate to animal cruelty, derogatory stereotyping, hatred, intolerance, tragedy or violence including items targeted at a younger audience deemed inappropriate
- Online learning
- Plants or plant products that are illegal including seeds, any items deemed a controlled substance, and pesticides
- Ticket reselling for concerts, events and festivals
- Travel reservation services and travel clubs, including airlines, cruises, and timeshares
- Unauthorized copies or reproductions of artwork that violate any copyright or trademark including stolen or counterfeit luxury items
